Professor (Dr.) Pradeep Kumar Joshi served the Union Public Service Commission as a member from May 12, 2015 to August 06, 2020 and then as the Chairman, from August 07, 2020 to April 04, 2022. Prior to this, he served as Chairman, Chhattisgarh Public Service Commission and also Chairman, Madhya Pradesh Public Service Commission. He also served as Director, National Institute of Educational Planning & Administration (NIEPA), [Ministry of HRD, Government of India]. The position of Director has been changed to Vice Chancellor & NIEPA has been changed to NUEPA (National University Educational Planning & Administration). Prof. Joshi did his Post Graduate Degree in Commerce in 1977 and Ph.D. Degree in Commerce in 1981 from Kanpur University, Kanpur. Professor Joshi has been in the field of education for more than 28 years. He served as the Professor, Head & Dean, Faculty of Management Studies, Rani Durgavati University, Jabalpur (MP) since May 2000 to 12th June 2006.

He also served as the Chairman, Board of Studies and Chairman, R.D.C. in Business Administration, Rani Durgavati University, Jabalpur (MP) during that period (till June 2006). Prior to that, he served Department of Business Administration, Rohilkhand University, Bareilly (UP) and Bareilly College, Bareilly (UP) as Reader. Professor Joshi has held several administrative positions during his tenure as an Educator. He has been the Member of various National and State Level Committees under the Government of India. He was the Member at State Level Committee for the Commemoration of 50th Anniversary of Indian Republic in Ministry of Culture, Government of India; Former Member, Steering Committee, Commission for Reform in Education under the Ministry of HRD, Government of India; Former Member, Steering Committee-cum-clearing House for Distance Education under the Ministry of HRD, Government of India; Former Member, National Resource Group for Sarva Shiksha Abhiyan [SSA], Ministry of HRD, Government of India; Former Member, Teacher Education Approval Board, Ministry of HRD, Govt. of India; Former Member, Central Advisory Board of Education (CABE) – this is the highest advisory body to advise the Central and State Governments in the field of education. Professor Joshi has been an eminent researcher and educationist having more than 28 years of teaching experience. He specialized in the field of Financial Management, Financial Control, Management Accounting, Taxation, Rural Development Management, Management in Panchayati Raj Institution & Khadi Gramodyog etc. He has published and presented research papers in several national and international conferences and seminars. Being an active educationist, he has delivered lectures and had academic interactions in various foreign countries like Belgium, Holland, England, Nepal and Japan. He has supervised 19 scholars for their Ph.D. Degree and around 24 Dissertations have been submitted under his guidance.

Prof. Smriti Kumar Sinha assumed the role of Vice Chancellor, at Pragiyotishpur University, on 10th May 2023. He was one of the first three founding faculty members of Tezpur University, a central University established in 1994. Within a short span of 28 years, Tezpur University earned many accolades. Prof. Sinha was the founder of the Department of Computer Science and was the responsible person for bringing computer culture to academics and administration. In addition to teaching and research, he also shouldered different administrative responsibilities in his 29 yearlong services in the University in different roles— member, Board of Management; Dean, Students' Welfare; founder Head of the Department of Computer Science; Dean, School of Engineering; Director, Digital Learning Centre and Advisor, Centre for Endangered Languages. Prof. Sinha's areas of research interest are Machine Translation, Computational Linguistics, Social Network Analysis, Web Services, Workflow, and Security. He has one European and two United States patents in Computer Science. Under his guidance, five students received their Ph. D. degrees till today. He has many research articles published in journals and proceedings. His creative endeavours contribute beyond science and technology. He is actively engaged in the domains of culture and literature.

For the last 35 years, he has been actively working for the revitalization of his endangered mother tongue, the Bishnupriya Manipuri language. He published three short story collections. Seducing the Rain God, an English translation of his short story collection is internationally acclaimed. His stories are also translated into Assamese, Bengali, and Kannada.

Prof. Smriti Kumar Sinha's workspace is the intersection of administration, academics, culture, and literature.

An academician and administrator with long years of experience, Dr. Kakati has about 30 years of teaching, academic administration, and research experience and completed his post-graduate degree at Gauhati University and Ph.D. at North Bengal University. Dr. Kakati served as a Lecturer in History at North Kamrup College, Baghmara, served as an Associate Professor at Bajali College, Pathsala, as the Principal at Rangia College, as the Academic Registrar at Gauhati University, as the Principal at Pandu College, Guwahati. He served as the Honourable Governor's Nominee to the Executive Council, at Bhattadev University. He is of experiences to hold various positions like NAAC's Peer Team Member; Member, of the District Scrutiny Committee for College Provincialization, Govt. of Assam; Member of the High-Level Committee for NEP Implementation, Govt. of Assam; Member, of Assam Higher Secondary Education Council; Resource Person in Human Resource Development Centre, Gauhati University. He also chaired the technical session of ICSSR sponsored National Seminar at Kumar Bhaskar Varma Sanskrit and Ancient Studies University and ICHR sponsored National Symposium at Gautam Buddha University. Uttar Pradesh. He has published 1 book; 2 edited books in addition to a number of research papers in UGC Care listed and peerreviewed journals. He is a Ph.D. research Guide at the Department of Folklore Research, Gauhati University.

SERF- THE SPONSORING BODY



Shankardev Education and Research Foundation (SERF) is a Trust formally established with its registration on 7th September 2021 at Guwahati. It's a voluntary organization envisioning quality higher education along with inculcating in students the sense of Bharatiya life values. SERF aims to work on two fronts towards realising the envisaged objectives: 1. Developing Institutions and 2. Collaborate with Institutions. As a part of its first objective, Pragjyotishpur University has come into existence with the enactment of Pragjyotishpur University Act NO XLVI of 2022 by the Government of Assam. Now, the SERF is the Sponsoring Body of Pragjyotishpur University.

This was the biggest Education Conclave in north-east India in recent years where the Chief Minister of Assam, Dr. Himanta Biswa Sarma, the Union Education Minister, Shri Dharmendra Pradhan, 5 education ministers from the state of Manipur, Sikkim, Arunachal Pradesh, Meghalaya, and Assam and representatives of three education ministers of Nagaland, Mizoram, and Tripura and the resource persons from various reputed organizations i.e. UGC, AICTE, NCERT, NCTE, IIM, IIT, Central Universities, Colleges and Schools actively participated. The conclave aimed to illustrate the basic premise of NEP 2020 along with its challenges and experiences related to its implementation in some of the major states in India.
